The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 02/11/2022, and investigated by Kelli Dunne.

A statement of childcare allegation, CPL-5223, was provided on 02/17/2022.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 6. Discipline and Guidance (c) Children in care shall not act as or be employed as staff or be allowed authority over other children.

Allegation: It was reported that in February of 2022, a child in care was directed to supervise other children in a room without a staff member present.

Explanation of Findings: During this investigation and through interviews conducted, it was established that in February of 2022, a child in care was directed to supervise other children in a room without a staff member present.

Action Required: Action required: The practice of children in care supervising other children in care needs to stop immediately. A Corrective Action Plan needs to be completed detailing how the facility will ensure that children in care will not supervise other children in care and return to Licenser by 3.9.22.
