The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 01/06/2021, and investigated by Kelli Dunne.

A statement of childcare allegation, CPL-5036, was provided on 01/11/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 3. Provider, Director, and Staff Requirement
(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Allegation: It was discovered on 1.5.2021 by Licenser KD during a telephone call with Provider that central registries had expired for herself and adult household member for a period of 13 days. Childcare Licensing Rules require that all staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year.

Explanation of Findings: It was discovered on 1.5.2021 by Licenser KD during a telephone call with Provider that central registries had expired for herself and adult household member for a period of 13 days. This allegation was found to be non compliant.

Action Required: A central registry was expedited for provider and a central registry along with a variance was submitted for adult household member. A corrective action plan needs to be completed detailing how this will not happen again.

If you disagree with the Department's finding of non-compliance for a violation, you may request an Administrative hearing within (10) days of your receipt of this letter (W.S. 14-4-108). Administrative hearing procedures are included in the Department of Family Services' **Wyoming Child Care Licensing Rules, Chapter 3, Section 5: Contested Case Hearing Rules**, and based upon the above statute. If you have questions, or need a copy of the Rules, you may contact the Department of Family Services Field office in the county where you live.
