In programs that are operated on a drop-in basis, immunization records for children are not required, but recommended to be on file. If attendance on a drop-in basis exceeds 30 calendar days, immunization records are required;

Explanation of Findings: During the 03/27/2019 Facility Visit it was observed that a child's record was missing immunization records.
