The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 10/08/2019, and investigated by Irene Maurer

A statement of childcare allegation, CPL-44425, was provided on 10/10/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements  
Section 14. Health and Safety Requirements  
(p) Chemicals shall not be used around children and in a manner that contaminates surfaces such as tables, carpets, lawns, food, or food preparation areas.

Explanation of Findings: Observed used rags & bottle of bleach to right of entry accessible to children.

Action Required: Moved out of reach of children during visit. Please provide a CAP for violation.

Action Met Comments: Received CAP stating teachers, cleaning staff, & board of directors were informed of the violation and the new procedures put in place to become compliant. Each Monday before school and after cleaning crew has left, teachers & directors will check to see that the recycling & rags have been put away for the week.

If you disagree with the Department's finding of a non-compliance violation, you may request an Administrative hearing within (10) days of your receipt of this letter (W.S. 14-4-108). Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
