The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 10/12/2021, and investigated by Joshua Seilaff.

A statement of childcare allegation, CPL-5161, was provided on 10/12/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 3. Provider, Director, and Staff Requirement

(a) Before the provider, director, their staff, household member, substitute or volunteer assume responsibility for the direct care of children, work in the facility or move into the Family Child Care Home or Family Child Care Center, the following shall be on file:

(iii) A child abuse/neglect Central Registry check which does not reveal any disqualifying information.

Allegation: Reporter alleges that Tamara Honda is working as staff and providing direct care for children on today's date without having out of state central registry on file.

Explanation of Findings: Evidence supports a finding of non compliance.

Action Required: Please submit a corrective action plan to child care licensing that includes a current CCL 205 staff summary listing qualifications for all staff at the facility. Please include how the facility will ensure that all out of state central registry is on file and completed for any staff person with an address that is out of state within the last five years on their central registry application. Please include supporting documentation showing that out of state central registry has been submitted to Utah for Tamara. Future monitoring visits may occur.

Explanation of Findings: Evidence supports a finding of non-compliance.

Action Required: Please submit a corrective action plan to child care licensing stating how the facility will ensure that all central registry results and staff qualifications are on file and current for staff at all times. Future monitoring visits may occur.

If you disagree with the Department's finding of non-compliance for a violation, you may request an Administrative hearing within (10) days of your receipt of this letter (W.S. 14-4-108). Administrative hearing procedures are included in the Department of Family Services' **Wyoming Child Care Licensing Rules, Chapter 3, Section 5: Contested Case Hearing Rules**, and based upon the above statute.
