The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 04/29/2020, and investigated by Denise J Holte.

A statement of childcare allegation, CPL-4941, was provided on 05/05/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General RequirementsSection 6. Discipline and Guidance(d) The following behavior shall be prohibited in all child care settings:(ii) Rough handling of children, including but not limited to hitting, spanking, beating, shaking, pinching, pushing or other measures that could produce physical pain;

Allegation: It was self reported to licensing that on 4/28/2020, Jeri Massie, grabbed an almost 4 year old boy and left bruises on the upper arms.

Explanation of Findings: A finding of non compliant has been cited based on the self report and interviews documenting that a child was grabbed by the provider and marks also remained.

Action Required: Please complete the Corrective Action plan on or before 5/22/2020 for approval. Please explain how you are going to use the information learned from the recent Powerful Interaction training that you completed. You may keep a journal and document the times that the stress was coming and then how it was handled to reset your responses. You may include additional methods also. Monitoring will also be conducted by child care licensing.

Administrative hearing procedures are included in the Department of Family Services' **Wyoming Child Care Licensing Rules, Chapter 3, Section 5: Contested Case Hearing Rules**, and based upon the above statute.
