The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 07/30/2019, and investigated by Teddie Schrayner

A statement of childcare allegation, CPL-44067, was provided on 07/30/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 16. Outdoor Play Space

(i) Outdoor play equipment with a fall height of more than 24 inches shall be installed over a resilient surface covering the appropriate use zones:

(i) Equipment with a fall height of more than 24 inches but less than seven (7) feet shall have six (6) inches of uncompressed resilient surface, except sand;

Explanation of Findings: Play equipment is too close together to allow for required surfacing, and surfacing does not meet the 6 inch requirement.

Action Required: Play equipment must be moved to meet 6 ft. minimum use zone around each piece of equipment with a fall height of more than 24 inches. Surfacing in these use zones must be a minimum of 6 inches deep. Please send verification to the Licensing Office once equipment and surfacing has been moved to meet licensing requirements.
