The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 01/18/2019, and investigated by Pamela Konstant

A statement of childcare allegation, CPL-43080, was provided on 01/29/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements  
Section 14. Health and Safety Requirements  
(I) Potentially dangerous or unsafe items shall be made inaccessible to children.

Explanation of Findings: At the time of the inspection, Licensor Pamela Konstant observed sharp scissors within reach of children on top of the desk in the Fireflies room. Sharp tuna lids and cans, having been opened by can opener, stored in an accessible location under the sink in the Crickets room. Shaving cream and soap marked "Keep out of reach of Children" were stored in an accessible location within reach of children in the Lightning Bugs Room.

Action Required: Facility will immediately and this point forward make and maintain sharp and potentially dangerous items inaccessible. Facility will develop and submit a Corrective Action Plan for how they will monitor and maintain compliance with the safety requirement to keep potentially dangerous and unsafe items inaccessible.
