Allegation: It has been reported that on one or more occasions in the last two (2) months, a dog in the facility has attempted to attack parents or relatives who were dropping off and/or picking up children in care. Per the Wyoming Child Care Licensing Rules, any animal demonstrating aggressive behavior must be made inaccessible to children in care.

Explanation of Findings: There is not enough evidence to support a finding of non-compliance.

Allegation: It has been reported that on one or more occasions in the last two (2) months, a child in care was not changed for an excessive period of time, resulting in diaper rash. Per the Wyoming Child Care Licensing Rules, diapers must be changed as frequently as needed.
