The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 06/03/2020, and investigated by Teddie Schrayner

A statement of childcare allegation, CPL-45500, was provided on 06/03/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 19. Infant and/or Toddler Care

(b) Sleeping infants shall:

(vi) Be placed in the same or adjacent room with enough light to see each infant's face, to view the color of the infant's skin and to check on the infant's breathing;

Explanation of Findings: During the zoom meeting it was observed that the room where the infant was sleeping was too dark not allowing the provider to see the child's coloring or breathing.

Action Required: *During the zoom visit, Elaine tried to open the curtain to lighten the room and the baby woke up and was taken out of the room. Elaine did show me that opening the curtain allowed lighting to be able to see the child's coloring and breathing. Please submit a corrective action plan to the Licensing Office showing how you will assure that all times that children are sleeping in your bedroom, that there will be enough lighting to see coloring and breathing of children sleeping in the room, and that no future violations will occur.

Action Met Comments: Corrective action plan received. Elaine will no longer use blackout curtains to allow clearer view of children's color and breathing.

2. Finding: Non-Compliant

Regulation: Chapter 5. Rules for Certification Of A Family Child Care Home (FCCH)
Section 2. Capacity/Supervision Requirements

(b) There shall be at least one (1) adult staff supervising the care of children at all times and the following supervision requirements also apply:

(vi) Napping children who are not within sight of the staff person shall be within easy hearing distance at all times, be checked on every few minutes, once awake, and meet all other requirements.

Explanation of Findings: During the 06/03/2020 zoom Facility Inspection, it was observed that the bedroom door to the bedroom that an infant was sleeping in was closed. Elaine did open the door during the inspection.

Action Required: The bedroom door must remain open enough to see the child at all times when children are in the bedroom sleeping. Please submit a corrective action plan to the Licensing Office showing how you will assure that compliance will be met and that no further violations will occur.
