Explanation of Findings: Mixed group size in outdoor play are to be 27 children with 1,2,3,4,5 YO present. Max group size with 1 YO is 12. Adequate staff are on site to split into smaller groups and utilize rooms to separate groups.

Action Required: Utilize sepearate rooms and staff to create group sizes that are within ratio and max group size.
