The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 03/24/2022, and investigated by Amanda Jarrett.

A statement of childcare allegation, CPL-5254, was provided on 04/01/2022.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 19. Infant and/or Toddler Care

(b) Sleeping infants shall:

(ii) Be placed on a firm, flat surface for sleeping;

Allegation: Licensing received a report that on March 23, 2022 two (2) infants were observed to be asleep in infant swings for a period to exceed 15 minutes. Reporter states infants were not moved from the infant swings, where they were sleeping, to a flat sleep surface during the 15 minutes observed.

Explanation of Findings: Licenser completed an unannounced visit 4/01/2022 at 3:45pm. Licenser observed 38 children with infants-school age in a mixed group setting with 3 staff present. Licenser observed 1 infant sleeping in an infant swing. Licenser observed 2 infants, awake in infant swings, alone in adjacent classroom, with the door to the classroom closed. Licenser observed the facility to be out of ratio in all rooms. Licenser observed 0 children/staff in the Infant/Toddler side of the facility as they were all combined in the 2 year old through school age side of the facility. 4 infants and 1 staff were moved to Infant/Toddler side; Owner and Director returned to facility by request of staff, bringing the facility into ratio during Licenser's visit.

Action Required: Corrective Action Plan to include providing licensing 2 weeks of sign-in/out sheets, 2 weeks of staff sign-in/out sheets to begin March 21, commencing April 1, 2022. Owner and Director will outline the facility's infant sleep plan, following Child Care Licensing Rule standards and how all staff will carry out plan daily. A copy of this plan will be submitted to Licensing. Owner/Director will identify to licensing a

statement signed and dated by all staff showing an understanding of and willingness to abide by the facility's safe sleep plan. 4 infants and 1 staff were moved to Infant/Toddler side; Owner and Director returned to facility by request of staff, bringing the facility into ratio during Licenser's visit.
