The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 06/04/2019, and investigated by Teddie Schroyer

A statement of childcare allegation, CPL-43851, was provided on 06/06/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

(c) Staff:child ratios and maximum group size shall be maintained as follows (Table 4-1) during all hours of operation when facilities care for only one (1) age group:

Explanation of Findings: During the 06/04/2019 Facility Visit it was observed that there were 16 children aged 0-5 yrs, outside w/2 staff and one staff was walking back and forth from infant room to playground.

Action Required: Please submit a corrective action plan to the Licensing Office, showing how all staff/child ratios and group size will be maintained at all times and staff will be located in each area of the facility.

(ii) Be placed on a firm, flat surface for sleeping;

Explanation of Findings: During the 6/4/19 Facility Visit it was observed there was an infant sleeping in a rock n sleeper.

Action Required: Please submit a corrective action plan to the Licensing Office showing how you will assure that all infants will be slept per Child Care Licensing rule. *Infant was removed from Rock N Sleeper during the visit.
