The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 10/29/2019, and investigated by Teddie Schrayer

A statement of childcare allegation, CPL-44542, was provided on 11/01/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 16. Outdoor Play Space

- (i) Outdoor play equipment with a fall height of more than 24 inches shall be installed over a resilient surface covering the appropriate use zones:
- (i) Equipment with a fall height of more than 24 inches but less than seven (7) feet shall have six (6) inches of uncompressed resilient surface, except sand;

Explanation of Findings: Playground equipment does not meet minimum surfacing requirements and is not inaccessible to children which was previously required, due to surfacing.

Action Required: Playground surfacing needs added. or equipment must be made inaccessible to children. As discussed, the surfacing and use zones must be met, or the equipment must be made more permanently inaccessible. Please submit a corrective action plan, to the Licensing Office showing how you have achieved compliance.
