(iii) A child abuse/neglect Central Registry check which does not reveal any disqualifying information.

Explanation of Findings: It was found at an unannounced visit conducted on March 10, 2020, that one employee, RS, has been working in the facility with an expired central registry background screening.

Action Required: Immediately request a variance and new central registry for employee RS, before she is allowed to work in the facility again. Complete the enclosed Corrective Action Plan detailing how the facility will maintain compliance with the requirement to have current central registry results on file for all employees. Please particularly address existing employees who need central registry updated annually.
