(ii) Be placed on a firm, flat surface for sleeping;

Allegation: It has been reported that on November 16, 2021, an infant was propped up on a boppy pillow to sleep.

Explanation of Findings: Through evidence and interviews obtained over the course of this investigation, it has been found that an infant was propped on a boppy to sleep on November 16,2021.

Action Required: Immediately discontinue the practice of propping infants to sleep on boppy pillows. Complete the corrective action plan detailing how the facility will ensure infants are slept safely and according to child care licensing rules.
