The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 07/08/2019, and investigated by Irene Maurer

A statement of childcare allegation, CPL-43976, was provided on 07/10/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements  
Section 19. Infant and/or Toddler Care

(b) Sleeping infants shall:

(i) Be placed on their backs for sleeping, unless a licensed health care provider signs a waiver. If the infant has not been observed turning repeatedly from stomach to back and back to stomach by the provider, the infant shall be returned to his/her back for sleeping;

Explanation of Findings: Observed infant sleeping in a mamaroo/swinger/rocker equipment.

Action Required: Staff moved infant to firm flat surface to sleep. Please submit CAP stating how compliance will be maintained.
