Explanation of Findings: Evidence gathered through interviews with director, owner, and staff do not support a finding of non-compliance.

Explanation of Findings: Allegation unfounded based on up-to-date diaper logs. The facility has a log for each child in diapers and potty training. It was current at the time of the visit.

Explanation of Findings: The allegation is unfounded based on Licenser's observation. The garage door is disconnected and there were no bikes hanging in the motor room.
