(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Explanation of Findings: It was discovered by Licenser that (1) existing staff member is working without a current WY central registry and sex offender check.

Action Required: Staff member will not work until WY background and sex offender check have been completed or a variance request has been approved. A corrective action plan needs to be completed detailing how this will not happen in the future.

Action Required: Staff member will not work until out of state background check has been completed or a variance request has been approved. A corrective action plan needs to be completed detailing how this will not happen again in the future.
