The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 07/29/2021, and investigated by Denise J Holte.

A statement of childcare allegation, CPL-5130, was provided on 08/04/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 2. Capacity/Supervision Requirements

(c) Staff:child ratios and maximum group size shall be maintained as follows (Table 4-1) during all hours of operation when facilities care for only one (1) age group:

Allegation: During the summer of 2021 it has been reported that up to 41 school aged children have been taken to parks with 3 staff.

Explanation of Findings: The investigation revealed that a minimum of twice during the summer of 2021 a total of 41 school aged children were with 3 staff. The investigation also revealed that there have been occasions of 36 children with 2 staff. The Wyoming Child Care Rules regarding school age ratios are 1:16, 1:32 and 1:40. A citing of non compliant has been noted.

Action Required: Please write a Corrective Action Plan and submit to the licenser on or before 8/24/2021 indicating a plan/procedure where ratios will be followed at all times. Please include a training plan for the staff regarding ratios so they are followed at all times throughout the year.
