The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 08/04/2020, and investigated by Veronica Endecott

A statement of childcare allegation, CPL-45846, was provided on 08/04/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

## 1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 16. Outdoor Play Space (i) Outdoor play equipment with a fall height of more than 24 inches shall be installed over a resilient surface covering the appropriate use zones: (i) Equipment with a fall height of more than 24 inches but less than seven (7) feet shall have six (6) inches of uncompressed resilient surface, except sand;

Explanation of Findings: At the facility visit licenser observed a piece of Little Tykes play equipment with 2 pink/red color slides attached and the larger slide has a fall height is over 24 inches. This equipment was not installed over surfacing.

Action Required: Please send licenser picture of play equipment installed over surfacing or how you have made the larger slide inaccessible to children. Please send a Corrective Action Plan that ensures how you will keep all play equipment with a fall height of more than 24 inches installed over surfacing.
