The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 07/22/2022, and investigated by Michelle Tucker.

A statement of childcare allegation, CPL-5313, was provided on 07/28/2022.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 7. Child Care Center

Section 2. Capacity/Supervision Requirements.

(f) There shall be at least one (1) adult staff directly supervising children in each area of the facility where children are located at all times.

Allegation: It has been self reported by the facility that on July 22, 2022, the only staff member in the infant room left the room while an 11 month old infant was buckled in and asleep in a swing.

Explanation of Findings: Through interviews and evidence obtained over the course of this investigation, it has been found that on July 22, 2022, the only staff member in the infant room of the facility, SH, left the room while an 11 month old infant was buckled into and had just fallen asleep in a swing.

Action Required: The staff member involved in this incident has been terminated from employment at the facility. Complete a corrective action plan detailing how the facility will ensure that all infants are supervised at all times going forward.
