The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/22/2022, and investigated by Kelli Dunne

A statement of childcare allegation, CPL-49712, was provided on 09/22/2022.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Compliant

Explanation of Findings: It was found by Licenser during visit on 9.22.22 that there is not a qualified Director or Assistant Director on site.

2. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements  
Section 9. Training.  
(b) Within three (3) months of a person's start date and prior to assuming responsibility for unsupervised direct care of children, all staff shall receive the approved pre-service training, facility staff orientation training and Wyoming Early Learning Standards (Early Learning Guidelines and Early Learning Foundations) training (8 credits).

Explanation of Findings: It was found by Licenser during visit on 9.22.22 that (1) staff person is working unsupervised without the training that is required before assuming responsibility for unsupervised direct care of children.

Action Required: The practice of allowing staff who have not completed required training to work unsupervised with children, needs to stop immediately. A corrective action plan needs to be completed by the Director detailing how she will ensure that before staff work unsupervised will have completed all training required by child care licensing rules.
