The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 3. Provider, Director, and Staff Requirement

(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Explanation of Findings: It was discovered during renewal desk review and verified at visit that (1) staff member has been working with an expired central registry and sex offender check for a period of 7 weeks.

Action Required: Staff member may not work until central registry and sex offender check have been completed. A corrective action plan needs to be completed detailing how this will not happen in the future.
