The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 10/10/2019, and investigated by Veronica Endecott

A statement of childcare allegation, CPL-44541, was provided on 10/10/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 19. Infant and/or Toddler Care

(b) Sleeping infants shall:

(iii) Have nothing placed in or over the crib, bassinet, or play pen;

Explanation of Findings: Licenser observed child sleeping on floor on mat with attached blanket. Blanket was over the child and mat bottom was flipped up over the child and then child's own blanket was also over her. Child was about 6 months old according to staff.

Action Required: Infant was immediately uncovered and removed from mat. Please have staff take orientation and STARS approved safe sleep course. Fill out a Corrective Action Plan (CAP) ensuring that staff understands and maintains that no infant sleeps with anything with them ever.

2. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 19. Infant and/or Toddler Care

(b) Sleeping infants shall:

(viii) Not be swaddled without a licensed health care professional statement, including

instructions and a time frame for swaddling an infant, on file. Swaddling is prohibited for infants that have the ability to roll over independently. A one-piece sleeper or sack equipped with an attached system that fastens securely only across the upper torso may be used; however shall not restrict the arms, hips, or legs of the infant. The sleeper or sack shall be used to manufacturer's guidelines and shall not slide up around the infant's face; and

Explanation of Findings: Licenser observed a 4 month old infant fully swaddled with arms in total restriction.

Action Required: Infant was swaddled immediately. Staff will repeat staff orientation and complete a STARS approved safe sleep course. Fill out a Corrective Action Plan (CAP) ensuring how staff will never swaddle an infant.
