A statement of childcare allegation, CPL-46165, was provided on 09/24/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

## 1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 19. Infant and/or Toddler Care

(b) Sleeping infants shall:

(i) Be placed on their backs for sleeping, unless a licensed health care provider signs a waiver. If the infant has not been observed turning repeatedly from stomach to back and back to stomach by the provider, the infant shall be returned to his/her back for sleeping;

Explanation of Findings: Observed an infant in a crib to sleep with a blanket. Observed another infant in a fisher price swing asleep.

Action Required: Infant moved to a firm flat surface to sleep. Submit a corrective action plan detailing how infants will be sleeping properly. Compliance monitoring visits maybe conducted.

No blankets will be left on the side of cribs. If a child needs to be sat down they will be placed on the floor not in a swing. This is in effect immediately.
