- (a) Before the provider, director, their staff, household member, substitute or volunteer assume responsibility for the direct care of children, work in the facility or move into the Family Child Care Home or Family Child Care Center, the following shall be on file:
- (iii) A child abuse/neglect Central Registry check which does not reveal any disqualifying information.

Allegation: Reporter alleges that a staff person, Alexis Krall, is working in the facility as staff and providing direct care for children without having current central registry and sex offender registry results on file.

Explanation of Findings: Evidence supports a finding of non compliance.

Action Required: Please submit a corrective action plan to child care licensing stating how the facility will ensure that central registry and sex offender is up to date and current for all staff. Future monitoring visits may occur.
