The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 03/10/2022, and investigated by Teddie Schroyer.

A statement of childcare allegation, CPL-5242, was provided on 03/10/2022.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements  
Section 3. Provider, Director, and Staff Requirement  
(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Allegation: Provider states that Payton Baker, a staff member at the facility does not have current central registry and sex offender completed and on file as they expired on 02/19/22.

Explanation of Findings: Evidence supports a finding of non-compliance as WY Central Registry/Sex Offender found on file were dated 02/19/2021 and expired as of 02/19/2022.

Action Required: Please submit a corrective action plan to child care licensing stating how the facility will maintain current staff records for all staff. Future monitoring visits may occur.
