(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Allegation: Reported alleges that a staff person Alexandria Cordova is working at the facility on or about 11/16/2020 and consider as part of the staff:child ratio without having current and updated DCI/FBI Fingerprint results completed.

Explanation of Findings: A finding of non compliance is based off of the documentation presented to child care licensing for Alexandria Cordova's staff qualifications. The DCI/FBI Fingerprints on file are outdated and expired as of 10/01/2020.

Action Required: Please complete and submit a corrective action plan to child care licensing stating how the facility will ensure that staff qualifications are current, up to date, and on file at all times. Please completed a CCL 205 staff summary and submit to child care licensing to ensure compliance with all staff qualifications at this time. Future monitoring visits may occur.
